

**Clifton Park Adult Recreation Soccer League
2022-2023 Indoor Season Registration**

Season Information

- there will be two sessions in the season with each session having 9 games
- *Session 1* will run from early November 2022 through mid-January 2023
- *Session 2* will run from late January 2023 through late March or early April 2023 (no game on February 12)
- play will be on Sundays starting at 8:00 and ending at 9:00
- the play will be pick-up style (bring white and dark shirt each week – no grays)
- total league size will be limited to around 20 players; priority will be determined by playing history and timeliness of payment if there are more than 20 players who register
- play will take place at the *Afrims* facility in Malta
- *Afrims* requires a mandatory annual “membership” of their own (for insurance purposes) at a nominal cost for each player; this needs to be handled by the player separately from this registration
- because of the COVID-19 pandemic, *Afrims* may be requiring adherence to safety guidelines
